1. 5. The acceptance, by Seller, of any payment after the specified due date shall not constitute a waiver of the Buyer's obligation to make further payments after the specified due dates.
6. Dishonored checks will be subject to a fee of \$30.00 per occurrence.
7. If a legal proceeding is commenced to collect on this account, venue shall be in the county of Morgan and state of Alabama shall govern. Seller shall be entitled to recover reasonable attorney's fees, cost and disbursements in such proceeding, or appeal thereof. This accruing debt owed shall be added to Buyer's account.
